

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT
(READ CAREFULLY BEFORE SIGNING)

I, the undersigned ("Participant"), acknowledge that I have applied for instruction from Battle Born Krav Maga, LLC ("BBKM") in self defense disciplines, which may include, without limitation, Krav Fit, Fight Class, Weapons, tactical, phase training, Krav Maga, or any variations thereof (the "Instruction"). In consideration of being permitted to participate in any way in the Instruction, Participant hereby agrees as follows:

1. Participant fully understands and acknowledges that: (a) there are risks and dangers associated with participation in the Instruction which could result in bodily injury partial and/or total disability, paralysis and death; (b) any injuries suffered by Participant associated with participation in the Instruction may be compounded or increased by negligent rescue operations or procedures of the Releasees named below; (c) the social and economic losses and or damages that could result from the risks and dangers associated with participation in the Instruction are severe; (d) these risks and dangers may be caused by the action, inaction or negligence of Participant or the action, inaction or negligence of others, including, without limitation, the Releasees; and (e) there may be other risks associated with participation in the Instruction not known to Participant or that are not foreseeable at this time.

2. Participant accepts and assumes the risk and responsibility for any losses, costs, damages and injuries Participant may incur as a result of Participant's participation in the Instruction, however caused and whether caused in whole or in part by the negligence of the Releasees.

3. Participant represents that Participant has no physical disability, impairment or ailment that would prevent Participant from engaging in any exercise activity or that would cause physical activity to be detrimental or inimical to Participant's health, safety, comfort or physical condition, or that of others. Participant has been advised to seek approval from a licensed medical professional before participating in the Instruction.

4. Participant hereby releases, waives, discharges and covenants not to sue and agrees to indemnify and save and hold harmless BBKM, Krav Maga Global, other participants, any sponsors, the owners and/or lessors of the premises on which the Instruction takes place and any of their respective administrators, directors, managers, agents, officers, volunteers and employees (collectively referred to herein as the "Releasees") from all liability to the Participant, Participant's personal representatives, assigns, executors, heirs and next of kin for any and all claims demands, losses or damages and any claims or demands therefore on account of any injury, including, without limitation, the death of Participant or damage to property, arising out of or in any way relating to Participant's participation in the Instruction or any other activities involving BBKM.

5. Participant hereby agrees that prior to participating in any Instruction, Participant will inspect the facilities and equipment to be used in the Instruction, and if Participant believes anything to be unsafe, will immediately advise the instructors of such condition and refuse to participate. Participant understands and agrees that if at anytime Participant feels anything to be unsafe, Participant will immediately take all precautions to avoid the unsafe condition and refuse to participate further.

6. Participant agrees that this Release and Waiver of Liability and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Nevada and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE THE COMPLETE AND UNCONDITIONAL RELEASE OF THE RELEASEES OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
